

REVISED - Behavioral Health Redesign Brief:

Training Sessions for Medicaid Behavioral Health Providers on Evaluation and Management (E/M) Services

The Ohio Department of Medicaid (ODM) and Ohio Department of Mental Health and Addiction Services (OhioMHAS) are sponsoring four regional trainings on the coding changes that will take effect ~~January 1, 2017~~ **July 1, 2017**.

These coding changes are specific to mental health pharmacological management services and substance use disorder medical/somatic services. Behavioral health providers will be able to begin rendering and billing for E/M office visits (medical appointments) using Current Procedural Terminology (CPT) codes 99201-99205 for new patients or 99211-99215 for established patients.

This training will inform provider agencies about the standards of medical practice and documentation to support office based E/M services for behavioral health patients and under what circumstances “add on” codes may be used for accompanying psychotherapy services and associated interactive complexity. Training sessions are free and open to all Ohio Medicaid providers of mental health and addiction services.

Training is being provided by Ms. Diane Zucker, M.Ed., CCS-P. Ms. Zucker is a health care management and reimbursement consultant who has nearly 30 years of experience in educational programming for physicians, practices and various agencies and facilities. She has a Master of Education degree and Bachelor of Social Work degree from Kent State University, with additional coursework in health care management and reimbursement. Prior to consulting, Ms. Zucker worked as a psychiatric social worker, counselor for the Bureau of Vocational Rehab and medical social worker. She is a certified CPT coder and ICD-10-CM trainer through the American Health Information Management Association (AHIMA) since 1997.
