

## Provider Enrollment and CBHC Universal Roster Update

### CBHC UNIVERSAL ROSTER

On April 30<sup>th</sup>, the Ohio Department of Medicaid (ODM) held a webinar introducing the community behavioral health center (CBHC) Universal Roster – a single roster to be submitted by CBHCs when reporting staff changes to all managed care plans (MCPs).

The CBHC Universal Roster template is now available on the BH Redesign website at <https://bh.medicaid.ohio.gov/training> and <https://bh.medicaid.ohio.gov/manuals> (under Enrolling Practitioners in Medicaid). **Effective May 1<sup>st</sup>, all MCPs will accept the CBHC Universal Roster from providers.**

**MITS is the primary source of provider enrollment information. The CBHC must make staffing updates in MITS before submitting any updates to the MCPs via the CBHC Universal Roster.**

As a reminder, the Universal Roster is only for CBHCs (PT84/PT95) and is intended to notify the MCPs of staffing changes (new hires, terminated employees, and staff with credential updates).
